Alan Ingram - Former Superintendent of Public Schools in Springfield, MA

Alan Ingram served for three years as Deputy Commissioner at the state education agency in Massachusetts where he provided executive level leadership to the Commissioner and Chairman of the Massachusetts Board of Elementary and Secondary Education on all policy matters related to advancing the Commonwealth's education agenda to prepare all public school students for success in college, career and life. Previously, Dr. Ingram served for four years as Superintendent of Public Schools in Springfield, Massachusetts, a district serving nearly 26,000 students in 44 schools.

Roslyn Johnson - Baltimore County, MD Department of Recreation and Parks

Roslyn Johnson, CPRP is the first female to lead the Baltimore County, MD Department of Recreation and Parks. She was unanimously confirmed three weeks before the County transitioned to teleworking due to COVID-19. She has a tenured past with the Rec and Parks profession and is a national leader having served on the Board of NRPA, taught at Directors School, has been a keynote around the world, and speaker at conferences to list a few. She's also on the Board of Directors of the prestigious American Academy for Park and Recreation Administration.

Steven Kahn – Math Corps

Professor Steve Kahn is the Director of the WSU Center for Excellence and Equity in Mathematics, a series of programs designed to produce success for Detroit students as they pursue their education from elementary and middle school through high school and college.
